Restrictions to the use of PFAS

Upcoming European measures to potentially restrict the use of the broad group of PFAS in PPE

Disclaimers:

- always check all details in the official regulation
- several restriction dossiers are under development
- restriction is not always a prohibition



Stockholm Convention - process

1. Proposal for listing a new chemical

Any party of the Convention, proposal should contain Annex D information

2. Apply screening criteria

Committee examines proposal, Secretariat invites Parties and observers to provide Annex E information

3. Develop a risk profile

Committee develops a risk profile and evaluates, Secretariat invites Parties and observers to provide Annex F information

4. Develop a risk management evaluation

Committee develops a risk management evaluation and recommends to COP if the chemicals should be listed

5. List the chemical in Annex A, B, and/or C COP decides on listing

Stockholm Convention – PFAS

Global ban on Persistent Organic Pollutants (POPs), in Europe implemented by the POP regulation

- Chemicals list in Annex A (elimination)
 - PFOA (C8)
 - PFHxS (C6) (EU implementation on-going)
- Chemicals list in Annex B (restriction)
 - PFOS (C8)
- Chemicals proposed for listing
 - Long chain PFCAs (C9-C21)




Derogations for PPE

- PFOA: textiles for oil- and water-repellency for the protection of workers from dangerous liquids that comprise risks to their health and safety, until 4 July 2023;
- PFOS and PFHxS: no PPE derogations

Annex XVII of REACH

- C9-C14 PFCAs (entry 68)
- TDFAs¹ (entry 73)
- PFHxS, RAC-SEAC opinion published $2020 \rightarrow POP$ regulation
- PFHxA, RAC-SEAC opinion published $2022 \rightarrow Commission$ proposal June 2023
- PFAS in firefighting foams, RAC-SEAC opinion finalised June 2023
- Universal PFAS, consultation on-going till 25 September 2023

Derogations for PPE

- C9-C14 PFCAs: textiles for oil- and water-repellency for the protection of workers from dangerous liquids that comprise risks to their health and safety, until 4 July 2023;
- TPFAs: PPE not in scope of the restriction (mainly applicable to consumer spray products)
- PFHxA: next slide




PFHxA

PPE in scope of the PFHxA of the Annex XV dossier, derogations proposed

- RAC did not support derogations for PPE
- SEAC did support derogations for PPE:
 - personal protective equipment intended to protect users against risks as specified in Regulation (EU) 2016/425 of the European Parliament and of the Council, Annex I, Risk Category III (a), (c), (d), (e), (f), (h), (l);
 - personal protective equipment specifically designed for armed forces and in the maintenance of law and order against the risk categories listed in paragraph 8(b) and protective clothing specifically designed for armed forces and in the maintenance of law and order or other emergency response workers;
 - high visibility clothing fulfilling the requirements of EN ISO 20471 Class 3;

Universal PFAS

- Dossier is submitted January 2023 by DE, DK, NL, NO, SE
- Provide your input in the consultation (till 25 September 2023) https://echa.europa.eu/restrictions-under-consideration/-/substance-rev/72301/term
- Broad chemical scope (OECD 2021), including fluoropolymers
- Common concern: extreme persistence
- According to the current REACH legislation

process

• ECHA

- RAC : Risk Analysis Committee
- SEAC : Socio-Economic Analysis Committee
- Committees decided to work per sector food contact materials and packaging (+ hazard in RAC) are the first
- First draft opinion of RAC and SEAC discussed in September 2023
- Once SEAC opinion is agreed -> 60 day consultation (only on opinion).



process

- EU Commission drafts the legislation considering the reports of RAC and SEAC
 - Delegated act, so only scrutiny by Parliament and Council

- Structure input
